

PCE Whiz Quiz!

An Educational Program from PCE

Rules of the game:

- Divide chapter members into two teams.
- Distribute the cut-apart "questions" (pg 4) to those in attendance.
- Facilitator/leader reads numbered "answers." The member who thinks she has the correct "question" raises her hand and reads the card. (The correct response is in italics on the facilitator's page.)
- If she is correct, the team gets a point: if not, they lose a point.
- Give the missed "answer" again until the correct "question" is given, adding or deleting points as appropriate.
- Continue until all answers and questions have been read.

Question: What is the year in which PCE became a project/philanthropy for P.E.O.?

2. \$3000

Question: What is the maximum grant that a PCE applicant may receive?

3. Is a citizen of the US or Canada; is not pursuing a PhD, law or medical doctorate degree program; has had 24 consecutive months as a non-student; is sponsored by a P.E.O. chapter; is studying in the US or Canada; is within 24 months of completing her degree

Question: What are the six (6) eligibility requirements for a woman applying for a PCE grant?

4. Ten (10) weeks

Question: What is the required number of weeks - before a grant is needed - that an application must reach the PCE office?

- 5. Distance learning, accelerated recertification program, accredited online program Question: What are examples of types of programs which are approved for PCE Grants?
- 6. Childcare, tuition, transportation expenses, books, uniforms, a computer Question: What are some of the items for which a PCE grant may be used?
- 7. Gasoline, bus fare, parking fees

 Question: What are the types of transportation expenses allowed by PCE?
- 8. Cosmetologist, CNA, LPN, RN, massage therapist, paralegal, X-ray technician, dental assistant, dental hygienist, music therapist, master's degree

 Question: What are career goals for which a PCE Grant may be used?
- 9. PCE Application forms dated October 2009.

 Question: Which PCE application forms should be used?
- 10. The P.E.O. Educational Loan fund

 Question: What is an additional P.E.O. project for which a PCE recipient may apply?

11. Applicant's need to reach her goal; assessment of goal in terms of marketable skill and job availability; type of employment applicant will seek at completion of educational program; applicant's available financial resources.

Question: What are four items of information which should be included in the Chapter Letter of Recommendation?

12. Loans, family assistance, other scholarships, savings/investments, extra hours at work, part-time job

Question: What is the applicant's financial plan if, even with the possibility of a full PCE Grant, she will still be short of money?

13. PCE Authorization to Release Information

Question: What is the form which must be signed by the applicant and her caseworker if the applicant receives state or provincial, US or Canadian government assistance and/or food stamps?

14. All questions answered on Application Form; addition correct on Income & Expense Form; required signatures on Chapter Recommendation Form; date chapter voted on applicant; Chapter Letter of Recommendation

Question: What are important steps in the application process that, if missing, may result in the application being returned to chapter for completion?

15. Six (6) months

Question: What is too far in advance of beginning of term to submit a PCE application?

- 16. Veterinarian, surgeon, attorney, orthopedist Question: What are career goals for which a PCE Grant may **not** be used?
- 17. Short statement by applicant about herself, her plans and her need. Question: What is additional information from candidate which is helpful to the trustees?
- 18. Mother, sister, grandmother, mother-in-law, aunt of the applicant Question: Who are those who should **not** write the Chapter Letter of Recommendation?
- 19. Car repairs, groceries, insurance payments, clothes and medical bills. Question: What are things for which the PCE grant may **not** be used?
- 20. An individual, a chapter, a group of chapters or reciprocity group. Question: Who are those who may create a PCE Named Grant of \$3000?
